This letter serves as the U.S. Department of Energy Environmental Management Los Alamos Field Office (EM-LA) and Newport News Nuclear BWXT – Los Alamos, LLC (N3B) submittal of information required by the New Mexico Environment Department (NMED) letter dated June 1, 2017, “Approval, Sediment Management Decision Tree Guidance” (HWB-LANL-17-018). In the approval letter, NMED requires submittal of an annual report that documents sediment management activities at Los Alamos National Laboratory by April 30 of each year.
