The Permittees will ensure that the sampling locations and depths proposed in the approved work plans for the SWMUs/AOCs identified are not affected by the demolition activities.

In the case of potentially adverse impacts on the SWMUs/AOCs observed in this notification, demolition activities will be documented to ensure that the potential impacts are appropriately identified and evaluated. Accordingly, if a demolition report is prepared for buildings that the NMED-HWB has identified in writing, the Permittees will provide a copy of the demolition



report to the NMED-HWB, within 30 days after the report is completed, in accordance with Section 1.17.3 of the Permit.
