The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE's) Extension Request for Submittal of Revised Work Plan for the Plugging and Abandonment of Wells and Boreholes for Fiscal Year 2019 (Request), dated August 7, 2019 and referenced by EM-LA-40DH-00490. The Request was received on August 7, 2019.

NMED notes that the revised work plan was due on August 6, 2019 and the extension request was received on August 7, 2019. DOE must submit extension requests in a timely manner to provide enough time for NMED to review and consider the request, prior to expiration of the due date.

NMED has reviewed the Request and notes that enough justification for the extension request was not provided. Instead DOE is requesting to meet with NMED to evaluate the scope and

address NMED's comments included in the Notice of Disapproval, dated June 7, 2019, for the above referenced document. NMED is amenable to a meeting and DOE must schedule a meeting within 15-days of the date of this approval letter to discuss the work plan.
