Request for Certificates of Completion for Two Solid Waste Management Units in the

Delta Prime Site Aggregate Area at Delta Prime East

Dear Mr. Kieling:

In accordance with Section XXI of the Compliance Order on Consent (the Consent Order), the U.S. Department of Energy Environmental Management Field Office (EM-LA) is requesting certificates of completion (COCs) without controls for the following two solid waste management units (SWMUs) within the Delta Prime (DP) Site Aggregate Area:

- SWMU 21-004(b), Aboveground Tank
- SWMU 21-004(c), Aboveground Tank

SWMUs 21-004(b) and 21-004(c) were recommended for corrective action complete without controls in the "Investigation Report for DP Site Aggregate Area Sites at DP East, Revision 1" (hereafter, the IR [document number EM2018-0140]) submitted to the New Mexico Environment Department (NMED) on December 19, 2018. The IR confirms that the nature and extent of contamination are defined or no further sampling is warranted at SWMUs 21-004(b) and 21-004(c). In addition, the IR demonstrates that the above-mentioned SWMUs pose no potential unacceptable risks or doses to human health under the industrial, construction worker, or residential scenarios and pose no potential unacceptable risk to ecological receptors. Therefore, neither site controls nor additional future actions under the Consent Order are necessary at these two sites.

The IR, including the recommendations for corrective action complete without controls for SWMUs 21-004(b) and 21-004(c), was approved in NMED's letter "Approval Investigation Report for DP Site Aggregate Area Sites at DP East, Revision 1" dated December 28, 2018 (HWB-LANL-18-037).
