Notice of Completion of Off-Site Waste Shipments for the First Quarter of Fiscal Year 2020 for Los Alamos National Laboratory as Required by the Federal Facility Compliance Order Site Treatment Plan, Compliance Plan, Activity 4.0

Dear Ms. Briley:

This letter notifies the New Mexico Environment Department (NMED) of the completion of off-site waste shipments for the first quarter of fiscal year (FY) 2020 for Los Alamos National Laboratory (LANL) by the U.S. Department of Energy (DOE) Environmental Management Los Alamos Field Office (EM-LA); the DOE National Nuclear Security Administration Los Alamos Field Office (NA-LA); Newport News Nuclear BWXT-Los Alamos, LLC (N3B); and Triad National Security, LLC (Triad) as set forth in the Federal Facility Compliance Order (FFCO) Site Treatment Plan (STP), Compliance Plan, Activity 4.0, regarding the shipment of mixed transuranic (MTRU) waste.

The following relevant activities took place during the first quarter of FY 2020 (October 1, 2019, through December 30, 2019):

- 1. DOE EM-LA/N3B shipped one (1) MTRU waste shipment (total volume of 3.148 m³) to the Waste Isolation Pilot Plant (WIPP) in Carlsbad, New Mexico, on October 1, 2019. This shipment contained six (6) 55-gal. drums and one (1) standard waste box (SWB). Table 1 presents the total volume of MTRU, sorted by treatability group. A copy of the waste manifest form is included in Enclosure 1.
- 2. DOE NA-LA/Triad shipped one (1) MTRU waste shipment (total volume of 2.912 m³) to WIPP in Carlsbad, New Mexico, on October 3, 2019. This shipment contained fourteen (14) 55-gal.

drums. Table 2 presents the total volume of MTRU, sorted by treatability group. A copy of the waste manifest form is included in Enclosure 2.

In the tables below, the MTRU waste volume is reported in cubic meters and rounded to three decimal places, as listed in the LANL waste management database. The LANL waste management database references the following: (1) a 55-gal. drum is 0.208 m<sup>3</sup> and (2) an SWB is 1.900 m<sup>3</sup>.
