STP-covered MLLW for disposal to Energy Solutions, LLC (ES) in Clive, Utah, on June 8 and June 22, 2022. Table 2 presents the total volume of MLLW shipped to ES by DOE EM-LA/N3B, sorted by treatability group.

Copies of the DOE EM-LA/N3B waste shipment tables are included in Enclosure 1, and the waste manifest forms are included in Enclosure 2.

- 1. DOE NA-LA/Triad shipped a total of sixty-two (62) 55-gal. drums of STP-covered MTRU waste for disposal to WIPP on April 7, April 13, April 21, June 16, June 21, June 23, and June 28, 2022. Table 3 presents the total volume of MTRU waste shipped to WIPP by DOE NA-LA/Triad, sorted by treatability group.
- 2. DOE NA-LA/Triad shipped nine (9) 55-gal. drums of STP-covered MLLW for disposal to Waste Control Specialist (WCS) in Andrew Texas, on June 6, 2022. Table 4 presents the total volume of MLLW shipped to WCS by DOE NA-LA/Triad, sorted by treatability group.

Copies of the DOE NA-LA/Triad waste shipment tables are included in Enclosure 3, and the waste manifest forms are included in Enclosure 4.

In the tables below, waste volumes are reported in cubic meters and rounded to three or four decimal places based on Waste Compliance and Tracking System tracking, as listed in the LANL waste management database.
