Dear Mssrs. Wyka and Mikolanis:

On December 9, 2022, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B) (collectively referred to as the Permittees) *Notification of a Class 1 Permit Modification to Update Contact Information and Emergency Equipment in the Los Alamos Hazardous Waste Facility Permit* (Notification) referenced by EPC-DO-22-308/LA-UR-22-31055.

This Notification updates Attachment D, Contingency Plan, in accordance with the code of federal regulations (CFR) 40, §270.42, Appendix I, Item B.6.d, and updates emergency contact information. This modification also removes references to alphanumeric pagers and is modified in accordance with 40 CFR §270.42 Appendix I, Item B.6.b, replacement with functionally equivalent emergency equipment.

NMED has updated the Permit, Attachment D, Contingency Plan, after ensuring compliance with the applicable permit modification regulations at 20.4.1.900 NMAC, incorporating 40 CFR §270.42 Appendix I, items B.6.b and B.6.d.
