Dear Theodore Wyka and Jeanette Hyatt:

On November 27, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B) (collectively referred to as the Permittees) *Class 1 Permit Modification to Update Contact Information and Upgrade Emergency Equipment in the Los Alamos National Laboratory Hazardous Waste Facility Permit* (Request) referenced by EPC-DO-23-322/LA-UR-23-31807.

NMED has incorporated the Class 1 Permit Modification Notification updating emergency contact information, and emergency equipment, in Attachments A and D of the Los Alamos National Laboratory Hazardous Waste Facility Permit. NMED has also corrected the spelling of Enewetak Drive in Permit Attachments A and N to be consistent with new signage adopted by the Permittee.

The Permit Attachments A, D, and N, were updated after ensuring compliance with the applicable permit modification regulations at 20.4.1.900 NMAC, incorporating 40 CFR §270.42 Appendix I, items A.2, B.6.b and B.6.d.
