Dear Theodore Wyka and Steven Coleman:

On December 23, 2024, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B) (collectively referred to as the Permittees) *Class 1 Permit Modification to Remove Structures from the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit*, (Request) referenced by EPC-DO-24-331/LA-UR-24-31442.

The Permittees have submitted this Request in accordance with the 40 Code of Federal Regulations (CFR) 270.42(a)(1), and Permit Section 3.1(3) a Class 1 modification requiring prior approval. NMED has reviewed the Request and determined that it conforms with 40 CFR 270.42 Appendix I Item A.1 "Administrative and Informational Changes".

NMED has reviewed the Request, and the Los Alamos National Laboratory Hazardous Waste Facility Permit (Permit) has been updated to incorporate the changes described in the Request. NMED has modified the unit descriptions in Permit Parts 1-11, and Permit Attachments: A, J, G.27, and N.
